	2-4 Restatements of information	In 2023 we became aware of industry-wide issues relating to the processing of food waste for animal feed and the possibility that this was being sent to anaerobic digestion. As a result, we have removed animal feed from our redistribution figures and assumed that this food has gone to waste. This means we have restated our 2022 figure from 27,836 tonnes to 28,308 tonnes – an increase of 472 tonnes – making our 2022 food waste figure 5.5% above our baseline rather than the 3.8% previously stated. This has also impacted our progress in 2023, with animal feed a growing part of our redistribution strategy. We aim to restart animal feed redistribution later in 2024.
	2-5 External assurance	All disclosures made in the report and on the website are checked and evidenced by internal experts. In 2021, we introduced a dedicated ESG claims management software system to capture and substantiate all our ESG disclosures. This was a significant milestone in how we govern and manage ESG credibly and transparently. However, due to the requirements of Competition Mergers Authority, the Bramley site and other acquired sites were under a 'hold separate' period until the site was finally released to be controlled and operated by Asda in October 2023. During the period of transition over to Asda's ownership pressure tests on the fuel pipelines did not highlight any issues, however during the remediation works at the site in February 2024 we became aware of a situation which uncovered historic damage to the fuel line. This continues to have a serious impact on the residents and businesses of Bramley and we have been transparent in setting out the steps to remediation, both for the site itself and the wider village. Given the complex and evolving nature of the situation we have continued to work proactively with other stakeholders as information becomes available to assess the most appropriate next steps to resolve this situation as quickly as possible.
